



LIMITED WARRANTY STATEMENT SOLAICO PHOTOVOLTAIC MODULES AND LUMINARIES

LIMITED WARRANTY – 10 YEARS REPAIR, REPLACEMENT OR REFUND

Solaico warrants the modules and luminaries to be free from defects in materials and workmanship. The duration of this warranty is 10 years from the date of delivery (Ex Works Solaico)

Claims under the warranty shall only be receivable if the buyer can provide the Prof. That the malfunction of module results exclusively from defects in materials and/or workmanship.

If the product fails to conform to this warranty, Solaico will, at its option, either repair or replace the product, or refund the purchase price.

This warranty does not cover failure of products due to improper application or installation, or due to special conditions of use unknown to Solaico.

LIMITED WARRANTY – LIMITED REMEDY

For all glass-Tedlar modules rated up 50W and up, but except for use in marine applications or in tropical or equatorial environment:

If, within twenty-five (25) years from the date of sale to the original purchaser, any module has a power output less than 80% of the minimum power specified at time of delivery, as measured at Solaico in both cases, then, provided that such loss in power is determined by Solaico (at its sole discretion) to be due to defects in material or workmanship, Solaico will replace such loss in power by either providing to the buyer additional modules to make up the total wattage loss, at a cost pro-rated for the time in service of the faulty module, or by repairing or replacing the module, at the option of Solaico.

For all glass -Tedlar modules rated at 50W and up

If, within ten (10) years from the date of sale to the original purchaser, any module has a power output less than 90% of the minimum power specified at time of delivery, as measured at Solaico in both cases, then, provided that such loss in power is determined

by Solaico (at its sole discretion) to be due to defects in material or workmanship, Solaico will replace such loss in power by either providing to the buyer additional modules to make up the total wattage loss, at a cost pro-rated for the time in service of the faulty module, or by repairing or replacing the module, at the option of Solaico.

For all Luminaries

If, within five (3) years from the date of sale to the original purchaser, any luminary has a malfunction due to defects in material or workmanship, Solaico will replace such luminary by either providing to the buyer a new luminary or repairing the malfunction of the luminary, at a cost pro-rated for the time in service of the faulty luminary, at the option of Solaico.

The remedy set forth in these paragraphs shall be the sole remedy provided under the warranty. The limited warranties set forth herein do not apply to any module or luminary which, in Solaico's judgment, has been subjected to misuse, neglect or accident, or which has been damaged through abuse, alteration, improper installation or application, or negligence in use, storage, transportation or handling, or has been repaired, or in any way tampered with. The limited warranties do not cover any transportation costs for return of modules or luminaires, or for reshipment of any repaired or replaced module or luminary, or cost associated with installation, removal or reinstallation of modules or luminaires.

The limited warranties set forth herein are in lieu of and exclude all other express or implied warranties, including but not limited to warranties of merchantability and fitness for a particular purpose or application, and all other obligations on the part of Solaico, unless such other warranties and obligations are agreed to in writing by Solaico. Under no circumstances shall Solaico be liable for incidental, consequential, or special damages, however caused.

HOW TO CLAIM YOUR WARRANTY

If you feel you have a claim covered by warranty, you must immediately notify the dealer who sold you the module or luminary under claim. The dealer will advise you on how to handle the claim. Contact Solaico if you require further assistance.

The factory will not accept the return of any modules or luminaires without prior written return authorization.

SEVERABILITY

If a part of the terms and conditions set out above is held invalid, void or unenforceable due to particular national or international legislation, it shall not affect other parts of the terms and conditions remaining.
